The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

CURATIVE SPOT TREATMENTS ON GOLF COURSE GREENS, TEES AND FAIRWAYS ONLY

Curative spot treatments are prescribed for controlling nematodes over smaller areas where outbreaks are severe or expected to become severe. To make a curative spot treatment apply the highest prescribed dose of Divanem [12.2 oz] and repeat up to 4

times at the prescribed intervals. For curative spot treatments treat no more than 10,000 sq ft per acre per year.

Curative Spot Treatment Use Restrictions:

- **DO NOT** apply when heavy rainfall is forecast.
- **DO NOT** apply within 25 feet of aquatic habitats (such as, but not limited to, lakes; reservoirs; rivers; permanent streams; marshes or ponds; estuaries; and commercial fish farm ponds).
