If in eyes	 Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

2.0 PRECAUTIONARY STATEMENTS

2.1 Hazards to Humans and Domestic Animals

CAUTION

Causes moderate eye irritation. Harmful if swallowed or absorbed through skin. Avoid contact with skin, eyes, or clothing. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals. Wash hands thoroughly with soap and

3.0 STORAGE AND DISPOSAL

STORAGE AND DISPOSAL

DO NOT contaminate water, food, or feed by storage or disposal.

Pesticide Storage

Store in cool, dry, well-ventilated area. Keep container closed when not in use. Do not store near food or feed. Ground water contamination may be reduced by diking and flooring of permanent liquid bulk storage sites with an impermeable material.

Pesticide Disposal

Open dumping is prohibited. Wastes resulting from the use of this product are acutely toxic. Improper disposal of unused pesticide, spray mixture, or rinsate is a violation of federal law. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into formulation equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration, or by other procedures approved by state and local authorities.

Container Handling [(greater than 5 gallons)]

Refillable container. Refill this container with pesticide only. **DO NOT** reuse this container for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the person refilling. To clean container before final disposal, empty the
