FIRST AID

CLEANING AND DISINFECTING WASHABLE HARD NON-POROUS SURFACES:

This product is for use on floors, walls, mirrors, glass, metal surfaces, conductive flooring, painted surfaces, bowl surfaces, empty basins, noncritical medical devices, hair/nail care instruments, showers, and lavatory fixtures, tanning beds and other hard, nonporous surfaces. Add one ounce of MAXIMA 128 to each gallon of water used. Always add MAXIMA 128 to premeasured water. Gently mix for a uniform solution. Apply solution by normal methods with brush, coarse spray devices, sponge, cloth or mop. Remove gross filth before cleaning and disinfecting begins. Thoroughly wet all surfaces, then remove excess solution with a wrung out applicator. Treated surfaces must remain wet for 10 minutes. For cleaning and disinfecting the following hard, non-porous surfaces: utensils, instruments, cages, kennels, stables, and catteries. Not to be applied to equipment used for animal food or water. Remove all animals and refered from premises, animal transportation vehicles, crates, etc. Remove all liter, droppings, and manure from floors, walls, and surfaces of facilities occupied or transversed by animals. Thoroughly clean all surfaces with soap or detergent and rinse with potable water. Saturate surfaces with a use solution of 1.0 oz. of Maxima 128 per gallon of water for a period of 10 minutes. DISPOSAL OF INFECTIOUS MATERIALS: Blood and other body fluids should be autoclaved and disposed of according to federal, state and local regulations for infectious waste disposal.

TOILET BOWL/URINAL DISINFECTANT/CLEANER APPLICATION

Remove gross filth or heavy soil prior to application of product.

From Concentrate. Add 0.75 oz. to the bowl. Brush thoroughly over exposed surfaces and under the rim, allow to stand for 10 minutes and flush.

From Use Solution. Empty toilet bowl or urinal and apply a 1 oz./gal. use-solution to exposed surfaces including under the rim with a cloth, mop, sponge or mechanical spray. Brush thoroughly over exposed surfaces and under the rim, allow to stand for 10 minutes and flush.

CLEANING AND DISINFECTING HARD NON-POROUS SURFACES ON PERSONAL PROTECTIVE EQUIPMENT (RESPIRATORS):

Preclean equipment if heavily soiled to ensure proper surface contact. Add one ounce of MAXIMA 128 to each gallon of water used. Always add MAXIMA 128 to premeasured water. Gently mix for a uniform solution. Apply solution to hard, non-porous surfaces of the respirator with brush, coarse spray device, sponge, cloth, or impression. Thoroughly wet all surfaces to be disinfected. Treated surfaces must remain wet for 10 minutes. Remove excess solution from equipment prior to storage. Comply with all OSHA regulations for cleaning respiratory protection (29 CFR§ 1910.134).

BARBER/BEAUTY SHOPS:

Use 1 oz. per gallon of water to disinfect hard, nonporous instruments and tools. Completely immerse combs, brushes, rollers, razors, scissors, blades, manicure and other salon instruments and tools for 10 minutes. For heavily soiled instruments and tools, a preliminary cleaning is required. Rinse thoroughly and dry before reuse. Prepare a fresh solution daily or more often if the solution becomes visibly cloudy, dirty, or soiled.

Note: Plastics may remain immersed until ready to use. Stainless steel shears and instruments must be removed after 10 minutes, rinsed, dried, and kept in a clean, non-contaminated receptacle. Prolonged soaking may cause damage to metal instruments.

LAUNDRY ADDITIVE TO SANITIZE AGAINST BACTERIA IN COMMERCIAL - INDUSTRIAL - FACILITIES

Maxima 128 sanitizes laundry such as bedspreads, sheets, pillowcases, diapers, towels, and other wet linens by reducing the growth of bacteria. Add 16 ounces of Maxima 128 per 100 pounds of dry laundry to the final rinse cycle. At this level Maxima 128 is an effective sanitizer in hard water up to 200 ppm.

This product is not to be used as a terminal sterilant/high level disinfectant on any surface or instrument that (1) is introduced directly into the human body, either into or in contact with the bloodstream or normally sterile areas of the body, or (2) contacts intact mucous membranes but which does not ordinarily penetrate the blood barrier or otherwise enter normally sterile areas of the body. This product may be used to preclean or decontaminate critical or semi-critical medical devices prior to sterilization or high level disinfection.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE: Store in original container in areas inaccessible to small children. Keep container closed when not in use. Do not reuse empty container.

PESTICIDE DISPOSAL: Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture or rinsate is a violation of Federal Law.
