

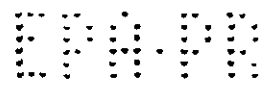

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

Prepare a sanitizing solution by dissolving 1 oz. or 2 oz. of DART 868 SANITIZER per 10 gallons of water. This gives a solution containing 100 ppm or 200 ppm available chlorine respectively. Clean and rinse item or surface prior to sanitizing. Then place dishes, glasses, equipment or utensils in the solution or spread it over the surface to be sanitized. Let stand 2-5 minutes and then wipe excess away. Rinse items and surfaces with potable water prior to use.

The same solution should be used in food tank in immersion or spray type machines providing 2-5 minutes contact time for sanitizing dishes, glasses, food processing equipment and utensils. Clean and rinse items prior to sanitizing. After sanitizing step rinse well with potable water and dry. The items are then ready for use.

The sanitizing solution should be used promptly after mixing. If the solution is allowed to stand or is reused and tests show the level of chlorine has not been maintained, additional DART SANITIZER should be added to maintain minimum concentration of 100 ppm available chlorine.

STORAGE AND DISPOSAL

Keep product dry in tightly closed containers when not in use. Store in a cool well-ventilated area away from fire or open flame. In case of a decomposition isolate container if possible and flood with large amounts of water to dissolve all material before discarding. Place in trash collection or dispose at approved landfill area or bury in a place.
