

#### APPLICATION

ALGEX NO 815-M is used to inhibit the growth of algae, bacteria, and fungi in recirculating commercial and industrial cooling water systems Before treatment with ALGEX NO 815-M systems must be cleaned to remove algal growth, microbiological slime, and other deposits. Then the system should be treated with an initial slug addition of 6.9 to 13.9 fluid ounces of ALGEX NO 815-M per 1,000 gallons of water in the system. Repeat the initial dosage until control is evident. Subsequent slug additions of 2 3 to 13 9 fluid ounces of ALGEX NO 815-M per 1.000 gailons of water should be made every 1 to 5 days or as needed. The required frequency of treatment depends on the relative amount of bleedoff and the severity of the microbiological problem. Slug additions of ALGEX NO 815-M should be made to the sump of water cooling towers

# WARNING

### **KEEP OUT OF REACH OF CHILDREN**
