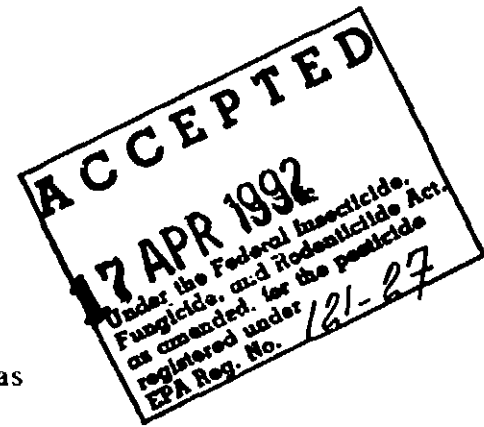

PHYSICAL/CHEMICAL HAZARDS: FLAMMABLE Do not use or store near heat sources, sparks or open flame.

STATEMENTS OF PRACTICAL TREATMENT:

IF SWALLOWED: Call Physician or Poison Control Center. Get Medical attention.

Hold unit 6-to-8 inches from skin and clothing while spraying, keeping sprayer pointed away from face. Slightly moisten skin or clothing. For maximum protection on skin, spread with hand after application. Frequent reapplication or saturation is unnecessary. Apply on face by first spraying small amounts in palm of hand and then spreading on face and neck. Do not apply to skin under clothing or the hands of young children. Wash treated skin after returning indoors. To repel ticks, chiggers and fleas, spray pant cuffs, socks and around openings in clothing. Will not damage nylon, cotton, wool. May damage some synthetic fabrics, plastic watch crystals, leather, painted or varnished surfaces. Wash treated clothing after use.

DISPOSAL: Do not reuse empty container. Rinse thoroughly and discard in trash.
