IF ON SKIN May cause skin reactions in rare cases. If so, wash with soap and water. Get medical attention if irritation persists.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Hold unit 6 to 8 inches from skin or clothing while spraying, keeping nozzle pointed away from face. Slightly tighten skin or clothing with a slow sweeping motion. Frequent reapplication and saturation is unnecessary. Apply on face by first spraying small amounts in palm of hand and spreading on face and neck. Do not apply to the hands of young children to repel ticks, chiggers, and fleas. Spray pant cuffs, socks and around openings in outer cloth. Will not damage nylon, cotton wool. May damage some synthetic fabrics, plastic, watch crystals, leather, painted and varnished surfaces.

DISPOSAL Do not reuse empty container. Discard in trash. Do not puncture or incinerate.
