Dear Mr. Kollath:

The proposed amendment to the label and Confidential Statements Of Formula(CSFs) for the product cited above are acceptable subject to the comments listed below:

1) Change the Precautionary Statements to read as follows:

Causes substantial but temporary eye injury. Harmful if swallowed. Do not get in eyes. Use of this product may cause skin reactions in rare cases. Wash treated clothing before wearing it again. Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet.

2) Change the First Aid section to read:

IF IN EYES:

- * Hold eye open and rinse slowly and gently with water for 15-20 minutes.
- * Remove contact lenses, if present, after the first five minutes, then continue rinsing.
- * Call a poison control center or doctor for treatment advice.

IF SWALLOWED:

- * Call a poison control center or doctor immediately for treatment advice.
- * Have person sip a glass of water if able to swallow.
- * Do not induce vomiting unless told to by a poison control center or a doctor.
- * Do not give anything by mouth to an unconscious person.

IF YOU SUSPECT A REACTION TO THIS PRODUCT:

- * Discontinue use.
- * Take off contaminated clothing.
- * Rinse skin immediately with plenty of water for 15-20 minutes.
- * Call a poison control center or doctor for treatment advice.

This product is not being re-registered at this time. Product specific efficacy data will be required. Once the efficacy guidelines are in place, you will be notified of the efficacy requirements.

A stamped copy of the revised label is enclosed for your records. Submit two copies of the revised finished label before the product is released for shipment under this amended label.

The CSF date June 11, 2001 for the basic formulation and the CSF dated August 23, 2001 for the alternate formulation are acceptable and have been made a part of the file for this product.
