We are also adding the claim "CONTAINS DEET [n, n-Diethyl-m-toluamide] as outlined in the EPA letter dated September 27, 2002 and adding optional directions for a single use towelette per PR Notice 98-10.



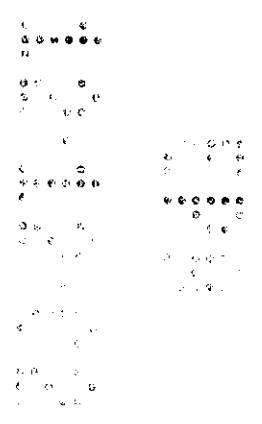
