PRECAUTIONARY STATEMENTS:

HAZARDS TO HUMANS. CAUTION: For external use only. May irritate eyes. Do not get in eyes or mouth. Harmful if swallowed. Avoid breathing spray mist or using in enclosed areas. Avoid contact with lips, open cuts, or irritated skin. Do not apply to excessively sunburned skin. Do not expose treated skin or clothing to fire, sparks or flame until liquid has evaporated. Do not smoke during application.

PHYSICAL AND CHEMICAL HAZARDS: EXTREMELY FLAMMABLE. Contents under pressure. Do not use or store near fire, sparks, or heated surfaces. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting.
