For added protection from ticks, wear shoes or boots, tuck pants into socks. Wear long sleeved shirt tucked into pants, inspect often for ticks.

### **PRECAUTIONARY STATEMENTS**

**HAZARDS TO HUMANS. CAUTION:** For external use only. May cause eye injury. Do not get in eyes or mouth. Harmful if swallowed. Avoid breathing spray mist or using in enclosed places. Avoid contact with lips, open cuts, or irritated skin. Do not apply to excessively sunburned skin. Do not expose treated skin or clothing to fire, sparks or flame until liquid has evaporated.

**PHYSICAL AND CHEMICAL HAZARDS: EXTREMELY FLAMMABLE.** Contents under pressure. Do not use or store near fire, sparks, or heated surfaces. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting.

### **STATEMENTS OF PRACTICAL TREATMENT:**

**IF SWALLOWED:** Call a physician or Poison Control Center. Get medical attention.

**IF ON SKIN:** May cause skin reactions in rare cases. If so, wash with soap and water. Get medical attention if irritation persists.

**IF IN EYES:** Flush with plenty of water. Get medical attention.

### **DIRECTIONS FOR USE:**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Hold unit 6-to-8 inches from skin or clothing while spraying, keeping nozzle pointed away from face. Slightly moisten skin or clothing with a slow sweeping motion. Frequent reapplication and saturation is unnecessary. Apply on face by first spraying small amounts in palm of hand and spreading on face and neck. Do not apply on skin under clothing. Do not apply to the hands of young children. For extra protection from crawling ticks, chiggers and fleas, use extra spray along all openings of clothing, such as neck band, waist band, pant and sleeve cuffs, sock tops and other areas where these insects may crawl under clothing. Wash treated skin after returning indoors and double-check yourself, other family members and pets for ticks. Will not damage cotton, denim, wool, nylon or Orlon. Do not apply on or near synthetic fabrics such as Rayon, Spandex or Dynel, leather, plastic watch crystals and painted or varnished surfaces. Wash treated clothing after use.

**DISPOSAL:** Do not reuse empty container. Wrap container, and discard in trash. Do not puncture or incinerate.
