On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. 1. Delete all text throughout the label marked with "strikethrough."

Directions for Use section comment(s):

- 2. The statement "STOP. Read and follow all ..." should be CAPITALIZED and relocated to appear immediately following the statement "It is a violation of ..." on its own line for prominence.
- 3. Replace the 5th sentence with: "To apply to face, squeeze a small amount of gel into palm of hand and apply sparingly, avoiding eyes."
- 4. To facilitate inclusion of required language from the DEET RED, replace the last 2 sentences with: "Use of this product may cause reactions in rare cases. If you suspect a reaction to this product, discontinue use, wash treated skin and call your local poison control center. If you go to a doctor, take this repellent product with you."

When the guidelines are finalized, the Agency expects to issue a Data Call-In to address the revised guidelines to all registrants with registrations for personal repellent products that have not previously submitted efficacy data sufficiently consistent with the revised guidelines.
