[Directions for canister:]

Remove the lid from the container by pulling upward. Remove the protective foil. Lift flap on lid. Pull up the center [towelette][wipe] and thread the corner of [towelette][wipe] through the open flap in lid; **DO NOT** push finger through lid opening. Replace lid on container. [Towelettes][Wipes] should be pulled at an angle to dispense at a time. The lid should be tightly closed on container between uses to keep [wipes] from drying out. [Alternate directions for a single packet towelette: Tear open foil pack.] Unfold towelette and wipe evenly over exposed skin. Excessive amounts should be unnecessary. Do not apply over cuts, wounds, or irritated skin. Do not apply near eyes and mouth. Apply sparingly around ears. When using on children, apply to your own hands and then put it on the child.
