- c. Change the statement, "Read Entire Label Before Each Use.", to read "Read and follow all directions and precautions on this product label.".
- d. Add a 1-800 phone number to the First Aid Section for medical treatment information.
- e. Add the following statements to the label:

Do not apply over cuts, wounds, or irritated skin. Do not apply near eyes and mouth. Apply sparingly around ears. When using on children, apply to your own hands and then put it on the child. Use just enough repellent to cover exposed skin. Do not use under clothing. Avoid over application of this product. Do not spray in enclosed areas. If used on face, spray on hands first and then apply sparingly and avoid eyes. Do not spray directly onto face. After returning indoors, wash treated skin with soap and water Wash treated clothing before wearing it again.

f. Label claims for the following pests are not supported and must be deleted from the label. Data may be submitted or cited to support the inclusion of these claims in a future label amendment:


