#### [Directions for canister:]

Remove the lid from the container by pulling upward. Remove the protective foil. Lift flap on lid. Pull up the center [towelette[wipe] and thread the corner of [towelette[wipe] through the open flap in lid; *DO NOT* push finger through lid opening • Replace lid on container. [towelettes][Wipes] should be pulled at an angle to dispense one at a time. The lid should be tightly closed on container between uses to keep [towelettes][wipes] from drying out. [Alternate directions for a single packet towelette: Tear open foil pack.] Unfold towelette and wipe evenly over exposed skin. Excessive amounts or more frequent reapplication should be unnecessary.
