On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

d. Add the following statements to the label:

Do not apply over cuts, wounds, or irritated skin.  
Do not apply near eyes and mouth. Apply sparingly around ears.  
When using on children, apply to your own hands and then put it on the child.  
Use just enough repellent to cover exposed skin.  
Do not use under clothing.  
Avoid over application of this product.  
Do not spray in enclosed areas.  
If used on face, spray on hands first and then apply sparingly and avoid eyes. Do not spray directly onto face.  
After returning indoors, wash treated skin with soap and water  
Wash treated clothing before wearing it again.

e. Label claims for the following pests are not supported and must be deleted from the label. Data may be submitted or cited to support the inclusion of these claims in a future label amendment:

Biting flies, ticks, Deer Ticks, Gnats, No-see-ums, Chiggers, Fleas

f. The claim for use on clothing is being accepted under the following conditions:

Data must be submitted to support the efficacy of the product when applied to clothing. A protocol for running the study must be submitted. Once the protocol has been approved, the data must be submitted within one year or you must delete the claim by submitting a label amendment to that effect. You must agree to these conditions.

g. Refer to the enclosed Efficacy review for comments on the marketing claims which must be deleted or modified.

h. In addition delete the following marketing claims:

i. The product must be packaged in containers utilizing a concave trigger to help aim the product or other comparable mechanism that will ensure that the product will not be inadvertently sprayed in the eyes.

j. Delete "water resistant" wherever it appears on the label.


k. Copies of the Efficacy and Product Chemistry reviews are enclosed for your reference..
