Hold 4 to 6 inches from skin while spraying, keeping nozzle pointed away from face. Slightly moisten skin. Excessive amounts or more frequent reapplication should be unnecessary. Do not apply over cuts, wounds, or irritated skin. Do not apply near eyes and mouth. Apply sparingly around ears. When using on children, apply to your own hands and then put it on the child.
