INSECTORFUME-10

POWERFUL, PENETRATING INSECTICIDE

For Use in All Types of Electric Sprayers

DIRECTIONS:

Remove pets, bird cages and fish bowls from rooms being sprayed.

When used in food processing plants, foods should be removed or covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. When using INSECTORFUME-10 as a space spray in these areas, apply only when plant is not in operation.

Fill electric sprayer with INSECTORFUME-10. Electric sprayer with time switch is preferable. Set time switch allowing it to run one minute per 1000 cubic feet for flies and mosquitoes. For all other insects, allow machine to run three minutes per 1000 cubic feet. Be sure that windows and doors are tightly closed while spraying. Keep room closed for at least fifteen minutes to two hours in order to get full benefit. Be sure that all fires are turned off while spray is being used.

INSECTORFUME-10 when atomized by an electric sprayer forms a penetrating mist that mixes with air and through natural circulation will penetrate to every part of the room.

FOR USE IN hotels, bakeries, restaurants, hospitals, stores, office buildings, apartments, dairies, warehouses, public buildings, clubs, theatres, etc.

INSECTORFUME-10 is effective against many forms of insect life and is guaranteed fatal to flies, fleas, moths, mosquitoes, bed bugs, silver fish.

FOR CONTROL OF ROACHES, SILVER FISH, WATER BUGS: Direct spray into cracks and other hiding places of insects. Thorough and repeated spraying of infested area is necessary for complete control. Most effective when insects are hit directly.

FOR CONTROL OF FLEAS AND TICKS: Same as for roaches, etc., but special attention should be given to repeated treatment of floors, baseboards, floor coverings and wall cracks, as well as sleeping quarters of the animals.

FOR CONTROL OF FLIES, MOSQUITOES, GNATS: Close up infested area and fill with mist; space should be left closed for at least ten minutes after treatment. Sweep up and destroy fallen insects at end of ten minute period.

FOR CONTROL OF MOTHS: Spray thoroughly all articles to be protected, paying particular attention to seams and folds. Spray thoroughly all interior surfaces of closets, trunks or other storage containers. Application should be repeated monthly unless treated articles are in moth-tight containers.

FOR CONTROL OF BED BUGS: Spray thoroughly bed and mattress and into cracks and hiding places, around baseboards, walls and floors. Repeat as necessary.
