AREA MOSQUITO APPLICATIONS ARE FOR USE ONLY BY MOSQUITO ABATEMENT DISTRICTS, PUBLIC HEALTH OFFICIALS, AND OTHER TRAINED PERSONNEL OF PUBLIC MOSQUITO CONTROL PROGRAMS.

MOSQUITO DUST # 1 is recommended for use wherever mosquito adults and larvae are a problem. It provides a long residual control and is as effective against DDT resistant strains as non-resistant varieties.

APPLICATION

For mosquito adult and larvae control, applications should be made to moist areas, standing water, and around the edges of large ponds, lakes, marshes, swamps, and tidal areas. Also dust around and in catch basins and similar areas where mosquitoes breed. For large area mosquito control, applications should be made to wet grassy, bushy, and woody areas. This dust is suitable for use in hand or power-operated dusters as well as with aircraft dust applicators.
