

SUGGESTIONS FOR USE

Apply when insects are on plants and when air is quiet, preferably in early morning. Do not mix or dilute this dust with other materials. Even coverage of infested plants is essential for control. Dosage per acre will depend on size of plants, type of duster, degree of severity of infestation. Use only sufficient material to effect desirable control.

RECOMMENDED USES

CUCUMBERS, MELONS, PUMPKINS, AND SQUASH: For the control of aphids, apply 25 to 30 lbs. per acre and repeat as necessary to maintain control. For powdery mildew, apply 20 to 30 lbs. per acre when first noted and repeat at 7 to 10 day intervals. From 3 to 10 applications may be required depending on length of growing season. On Cucumbers and Summer Squash, a maximum of 3 to 4 applications would be made to an individual set of fruit. Do not apply within 7 days of harvest.
