

**DIRECTIONS**

**BEFORE USE READ DIRECTIONS, CAUTION, ANTIDOTE AND NOTICE STATEMENTS CAREFULLY**

**IMPORTED FIRE ANT, (NON-CROP AREAS ONLY):** Broadcast Treatment—Apply 25 pounds of Heptachlor 5% Granular per acre to non-food crop areas including lawns, turf and nurseries. Mound Treatment—Apply 1 to 2 cups to entrance of the nest as well as to area 3 feet around nest. If necessary repeat treatment 2 weeks after first application. Do not apply to pasture lands.

**ROUGH-HEADED CORNSTALK BEETLE (Sugar Cane Beetle) ON CORN:** Apply 20 pounds of Heptachlor 5% Granular to the soil at time of planting.

**SOIL INSECTS:** For control of Japanese Beetle Larvae, White Grubs, White-Fringed Beetle Larvae, European Chafer Larvae and Asiatic Garden Beetle Larvae, apply 40 to 60 pounds (.9 to 1.35 lb./1000 sq. ft.), for Green June Beetle Larvae 60 to 100 pounds per acre (1.35 lb. 1000 sq. ft.), on non-food crops including lawns, cemeteries, golf courses, park areas and nurseries. Persons or pets should be excluded from the treated area until the Heptachlor has been worked or washed into the soil.

This product is toxic to fish and wildlife. Birds feeding on treated areas may be killed. Keep out of lakes, streams and ponds. Apply this product only as specified on this label.

Do not apply where runoff is likely to occur. Do not contaminate water by cleaning of equipment or disposal of wastes.

**CAUTION**


