SUGGESTIONS FOR USE

FOR TOBACCO PLANT BEDS: To control TOBACCO BLUE MOLD in the plant bed, it is necessary that this material be applied as a dust with a suitable dust gun without further mixing. Treatment of the plants should begin when the plants' leaves are the size of a dime. Dust twice weekly until transplanting time, making certain all parts of the bed receive an even and thorough dusting. If rain occurs between regularly scheduled applications, the treatment should be repeated as soon after the rain as practicable.

AMOUNT OF DUST REQUIRED TO COVER PLANTS:

1st to 4th applications — 1 to 1½

lbs. per 100 square yards

5th and 6th applications — 2 to 2½

lbs. per 100 square yards

All other applications — 3 to 3½

lbs. per 100 square yards
