**DIRECTION FOR USE:**

**HOUSEHOLD AND INSTITUTION** — To control roaches, dilute this concentrate at the rate of 1 part to 9 parts of water and spray into cracks and crevices, holes, behind baseboards, and wherever roaches may hide. Repeat when necessary.

**DAIRY ANIMALS** — To control horse flies and stable flies, dilute 1 part of concentrate to 9 parts of water and spray directly on animals, at the rate of 1 ounce per animal per day of the diluted product for daily protection or 1 to 2 quarts per animal every 3 days. Avoid wetting the hair of animal.

**GRAIN STORAGE** — To control exposed stages of granary weevils, rice weevils, confused flour beetles, cadellies, grain moths and sawtooth grain beetles in mills, elevators, granaries, warehouses and box cars — As a surface spray for killing exposed insects that hide in walls, floors or ceiling, dilute this concentrate with 9 parts of water and apply at the rate of one gallon per 500 cubic feet of surface.

**FOOD PROCESSING** — In bottling plants, breweries, food processing plants, canneries, bakeries, in markets, stores, institutional kitchens, and wherever foods are processed or prepared, Pyrenone assures safe, effective control of flying insects such as, chocolate moths, grain moths, house flies, fruit flies, gnats, mosquitoes and wasps. It also gives good control of exposed crawling pests such as, silverfish, crickets, spiders, and roaches, exposed stages of cadellies, grain moths, ants, floor beetles, and certain other common pantry pests. Diluted at the rate of 1 gallon to 9 gallons in Decolorized Base Oil, apply as a mist or aerosol in Ternair, Challenger, Microsol, or similar units at the rate of 1 liquid ounce per 1000 cubic feet of space. Use only when food processing plant is not in operation.
