DIRECTIONS FOR USE ON SHADE TOBACCO

IN THE BED: For the control of Blue Mold, Aphids, Thrips, Flea Beetles, Vegetable Weevils and Slugs. Apply at the following rates. Apply 2 to 4 lbs. per 100 square yards when plants are the size of a dime and before Blue Mold appears. Dust every 3 days.

IN THE SHADE: For the control of Aphids, Thrips, Flea Beetles, Budworms, Hornworms and Cabbage Loopers. Apply weekly, or as needed, at 20 to 30 lbs. per acre, depending on size of plants. "Florida Shade Dust" is formulated with "Ligno-

flex" a special Pecan Hull Flour Diluent approved for use on Shade Tobacco.

CAUTION

Do not apply to tobacco within 5 days of priming or 15 days of cutting. Workers should wear gloves where applications have been made within 30 days of cutting. Avoid plant juices coming in contact with the skin or other parts of the body when engaged in cutting the crop.

WARNING

FIRST AID TREATMENT

CALL A PHYSICIAN AT ONCE IN ALL CASES OF SUSPECTED PARATHION POISONING If symptoms or signs of poisoning include blurred vision, abdominal cramps and tightness in the chest don't wait for a doctor but give two atropine tablets each (1 100 gr.) at once, Remove patient immediately from the area where Parathion is present. Remove all contaminated clothing and wash clean with plenty (f soap and water to remove all traces of Parathion. If swallowed, induce vomiting by giving warm salty or soapy water.

PHYSICIANS' NOTE

Parathion is a cholinesterase inhibitor and treatment of severe poisoning should include the use of atropine; Endosulfan produce (s) central nervousyst m excitation which responds to the barbituric Macid derivatives.

Warning symptoms include weakness, headache, tightness in the chest, blurred vision, non-reactive pin-point pupils, salivation, sweating, nausea, vomiting, diarrhea and abdominal cramps.

TREATMENT

Give atropine, preferably by injection, grains 1.100 two or three tablets at once and parenterally or orally every hour as required up to 30 tablets or until pupils dilate. Never give morphine. Clear ches by postural drainage. Artificial respiration of oxygen administration may be necessary. Observe patient continuously for 48 hours. Repeated exposure to cholinesterase inhibitors may, without \mathcal{S} warning, cause prolonged susceptibility to very small doses of any cholinesterase inhibitor. Allow no further exposure until time for cholinesterase regeneration has been allowed as determined by /blood_tests.
