
The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Permethrin and Tetramethrin Interim Decisions and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

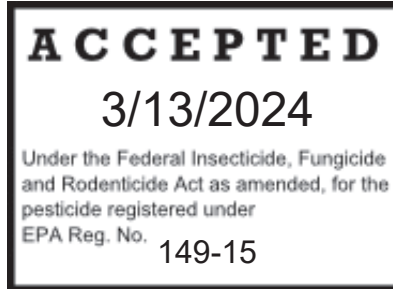

This pesticide is extremely toxic to aquatic organisms, including fish and aquatic invertebrates. For both indoor and outdoor use.

Terro® Stink Bug Killer [This product] provides effective control of listed pests in and on buildings, structures and their immediate surroundings. Permitted areas of use: apartment buildings, homes, and private residences.

### Use Restrictions

Do not allow adults, children, or pets to enter the treated area until sprays have dried. Do not apply this product in a way that will contact adults, children, or pets, either directly or through drift. Remove pets, birds, and cover fish aquariums before spraying. Do not apply as a broadcast or spot-treatment to indoor surfaces at residential sites or sites including nurseries, day care centers, schools, hospitals, and nursing homes.

Do not apply directly to sewers or drains, or to any area like a gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur, except as directed by this label.

Do not use in food/feed areas of food/feed handling establishments, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed or facility is in operation. Serving areas are areas where prepared foods area served such as dining rooms but excluding areas where foods may be prepared or held.

In residential areas, cover all food handling surfaces and cover or remove all food and cooking utensils or wash thoroughly after treatment. Do not apply where food is present. Terro® Stink Bug Killer [This product] may be used as a crack and crevice treatment or as a spot application in commercial non-food/feed areas. All areas where insects hide or through which insects may enter should be treated.

Do not apply directly to sewers or drains, or to any area like a gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur, except as directed by this label.

Remove pets and cover fish aquaria before spraying. Prevent re-entry of dogs and cats into treated area until spray deposits are dry.

**Indoor Use:**

Do not allow to enter indoor or outdoor drains. Follow proper disposal procedures on this label.

**CRACK & CREVICE INJECTION:** Hold container upright and tilt extension tube to a 90° angle with can and inject into cracks and crevices where insects may be hiding, living and breeding. Place injection tip ½ inch into cracks, crevices, holes and other small openings where insects may be a problem. Release a one-second spray per spot. In serious infestations, if possible, place spots approximately 12 inches apart. In light infestations or for preventative treatment, place spots approximately three feet apart. In long running cracks, move the injector tip along the crack while spraying. Move at the rate of one linear foot per second in heavy infestations and three feet per second in light infestations. See the additional directions below for effective control of specified insects.

**[To kill] Ants (except fire ants, pharaoh ants, carpenter ants, and harvester ants), Booklice, Boxelder Bugs, Crickets, Dermestids, Firebrats, [Multicolored] Asian Lady Beetles [Lady Beetles] [Lady Bird Beetles] Silverfish, Stink Bugs, and Sowbugs:** Apply as a spot or crack and crevice treatment. Apply thoroughly to all areas where these pests crawl and hide, especially in cracks and crevices, and hidden surfaces around sinks and storage areas, behind baseboards, around doors and windows, behind and under refrigerators, cabinets, sinks and stoves, the underside of shelves, drawers, bookcases and in similar areas.

**Spiders (except black widow spiders, brown recluse spiders, and hobo spiders):** Apply along and behind baseboards, to window and door frames, corners, pipes, storage localities, attics, crawl spaces and other areas over which these pests may crawl.

**Earwigs, Ground Beetles, Millipedes, Mole Crickets, [Multicolored Asian Lady Beetles [Lady Bugs] [Lady Beetles] [Lady Bird Beetles Pillbugs, Sowbugs, and Stinkbugs:** Apply around doors and windows and other places where these pests may enter premises. Treat baseboards, storage areas and other locations where these pests are found.

**PANTRY PESTS - Grain Beetles (Rusty, Merchant and Saw-toothed), Flour Beetles (Red and Confused), Chocolate Moths, Cigarette Beetles, Clover Mites, Cluster Flies, Drugstore Beetles, Elmleaf Beetles, Rice Weevils, Lesser Grain Borers, Spider Beetles and Tobacco Moths:** Treat exposed stages. Remove all foodstuffs, utensils and shelf paper from area to be treated. Discard used shelf paper and any infested foodstuffs. Apply spray to shelves and in cracks and crevices behind and under cupboards and cabinets. Allow spray to dry prior to replacement of food and utensils.

**Carpet Beetles (Black, Furniture and Varied):** Spray on and under edges of floor coverings, under rugs and furniture and in closets or other localities where these insects are found. Do not apply as a broadcast or spot-treatment to indoor surfaces at residential sites or sites including nurseries, day care centers, schools, hospitals, and nursing homes.

**Webbing Clothes Moths:** Use this product as a crack and crevice treatment in closets and other storage areas where these pests are found. This is an adjunct treatment and will not control moth larvae already on clothes. Do not apply to clothing.

**Outdoor Use:**

**Ants (except fire ants, pharaoh ants, carpenter ants, and harvester ants):** Spray freely around ant trails, doors and windows and other places where ants enter premises, around nests hidden under steps, brickwork, concrete, etc. Break apart accessible nests and spray freely on and around debris.

**PESTS ON OUTSIDE SURFACES OF BUILDINGS:** For control of building infestation due to **Ants (except fire ants, pharaoh ants, carpenter ants, and harvester ants), Clover Mites, Crickets, Earwigs, Millipedes, [Multicolored Asian Lady Beetles [Lady Bugs] [Lady Beetles [Lady Bird Beetles] Stink Bugs and Sowbugs (Pillbugs):** Spray foundation of building where insects are active and may find entrance up to a height of 2 to 3 feet. Apply as a residual spray to outside surfaces of buildings where insects tend to congregate. Spray areas include (but are not limited to) screens, window frames, eaves, porches, patios, garages and refuse dumps.

**Application Restrictions for Outdoor Use**

Do not water the treated area to the point of run-off. Do not make applications during rain. Avoid making applications when rainfall is expected before the product has sufficient time to dry (minimum 4 hours). Rainfall within 24 hours after application may cause unintended runoff of pesticide application. Spot treatments must not exceed two square feet in size (for example, 2 ft. by 1 ft. or 4 ft. by 0.5 ft.).

All outdoor applications must be limited to spot or crack-and-crevice treatments only, except for the following permitted uses:

- (1) Perimeter band treatments of 7 feet wide or less from the base of a man-made structure to pervious surfaces (e.g., soil, mulch, or lawn);
- (2) Applications to underside of eaves, soffits, doors, or windows permanently protected from rainfall by a covering, overhang, awning, or other structure;
- (3) Applications around potential exterior pest entry points into man-made structures such as doorways and windows, when limited to a band not to exceed one inch;
- (4) Applications to vertical surfaces (such as the side of a man-made structure) directly above impervious surfaces (e.g., driveways, sidewalks, etc.) up to 2 feet above ground level.

Do not apply the product into fish pools, ponds, streams, or lakes. Do not apply directly to sewers or storm drains, or to any area like a drain or gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur. Do not allow the product to enter any drain during or after application. Do not apply directly to impervious horizontal surfaces such as sidewalks, driveways, and patios except as a spot or crack-and-crevice treatment. Do not apply or irrigate to the point of run-off. Do not make applications during rain. Avoid making applications when rainfall is expected before the product has sufficient time to dry (minimum 4 hours). Rainfall within 24 hours after application may cause unintended runoff of pesticide application.
