CONTROLLING AND ELIMINATING ANTS (except fire ants, pharaoh ants, carpenter ants, and harvester ants): Ants may first come in large numbers but will soon disappear. This product is specifically formulated to allow worker ants to consume the product and survive long enough to carry the liquid back to the [nest and deliver a dose to the] rest of the colony. The key to obtaining effective control is to monitor the placements regularly and ensure there is always a fresh supply of bait at each placement. Complete control may take up to two weeks.

DO NOT use adhesive application [strips] [tape] on delicate surfaces such as unpainted walls, wallpaper or wood furniture finishes. Do not use insect killing sprays on or near bait stations as they may repel ants from feeding. 
