The amended labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable.

This approval does not affect any terms or conditions that were previously imposed on this registration. You continue to be subject to existing terms or conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one (1) copy of the final printed labeling before you release this product for shipment with the new labeling. In accordance with 40 CFR § 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR § 152.3.

Should you wish to add/retain a reference to your company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the U.S. Environmental Protection Agency (EPA). If the website is false or misleading, the product will be considered to be misbranded and sale or distribution of the product is unlawful under FIFRA section 12(a)(1)(E). 40 CFR § 156.10(a)(5) lists examples of statements the EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the EPA find or if it is brought to our attention that a website contains false

#### [HOW IT WORKS] [GENERAL INFORMATION]

TERRO® LARVACIDE [This product] is a selective microbial insecticide for use against mosquito larvae in a variety of habitats. The product can be applied to areas with plants, fish and other aquatic life and to areas used by or in contact with humans, pets, horses, livestock, birds, or wildlife. Once applied, the product [dissolves quickly to] release(s) a biological larvacide that is consumed by mosquito larvae, killing the larvae before they turn into biting adults [that may transmit viruses such as West Nile virus to people or heartworm disease to dogs and cats].

**[HOW TO USE] [USING TERRO® LARVACIDE]:** Place product on water surface in listed sites where mosquitoes may breed. Treat on basis of surface area by placing one (1) [water soluble] pouch for up to 50 sq. ft. of treatment area. There is no need to open [the water soluble][individual][pouches] as they will quickly dissolve [releasing contents].

#### For control of mosquito larvae in the following sites:

**Treatment Areas:** Ponds, bird baths, water gardens, flower pots and planters, rain barrels, fountains, gutters, unused pools, pool covers, hollow trees and tree holes, livestock watering troughs/tanks, ditches, discarded tires, and any location where water accumulates and remains standing for periods of time.\*\*
