

## DEXOL SYSTEMIC INSECTIONS

## For Roses - Shrubs - Flowers - Tomatoes

Read entire label and follow all cautions and directions. DEXOL SYSTEMIC INSECTICIDE protects roses, chrysanthemums, azealeas, pyracantha, spirea, pirch and other flowers and shrubs from damage by aphids, spider mites, thrip, leaf miners, white flies, lace bugs, leaf hoppers, and pine tip moths, DEXOL SYSTEMIC INSECTICIDE enters the plant through its roots and is translocated through natural growth and flow of sap to the entire plant. Working from inside the plant it kills sucking insects that feed on the plant.

apply DEXOL SYSTEMIC INSECTICIDE uniformly under the entire canopy of the plant and work into the soil watering thoroughly after application. Repeat in 4 to 6 weeks if required.

Use the following table for amount to use:

1 to 3' tall -4 tablespoons per foot of height

3 to 6' tall  $-\frac{1}{2}$  cup per foot of height

6 to 12' tall - 4 cup per foot of height

— Use following amounts and work into soil. Water thoroughly after application.

Before planting use one cup per 25 sq. ft. (5  $\times$  5) of area, set plant in normal manner and water thoroughly.

Growing flowers — put one level teaspoonful in narrow band around each plant.

1 or flowers in a row — use  $\frac{1}{2}$  cup to each 6 ft. of row in a narrow band near base of plants.

Potted Plants — use 1 level teaspoonful for each 6" pot. Mix thoroughly into top soil and drench with water.

For control of aphids, flea beetles, leafhoppers, leaf miners, and mites, use as follows: In planting seed use  $1\frac{1}{2}$  cups per 50 ft. of row in furrow with seed.

In transplanting put 2 level teaspoonfuls per plant in the transplant hole and mix with soil before setting plants.

Use DEXOL TOMATO LIFE to help set the fruit.
