(For Leaf Miners, apply when leaves are expanded [about mid-May] and repeat in early July.) Boxwood: Leaf Miners, Mealybugs, Mites- Apply 2 tbsp. in 3 gal. water. (For Leaf Miners, apply in spring when Leaf Miner Flies first appear or in early summer for control of larvae in the infested leaves.) Camellias: Aphids, Camellia Scale, Mites, Tea Scale- Apply 2 tbsp. in 3 gal. water. (foliar Spray: Apply 2 sprays 6 weeks apart the first year followed by annual application soon after first growth begins in the spring. HOUSEFLIES
