USE DIRECTIONS

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Read entire label. Apply in accordance with specifications. Do not spray where people or pets are, or on food or dishes. **DEXTOL DEXA-KLOR** is a pesticide. It kills and repels insects attacking home and other structures. It is effective against the following insects:

PESTS OF LAWNS—For control of Ants, Armyworms, Brown Dog Fleas, Fleas, Grasshoppers, Crickets, Beetles, Cicadas, Earthworms, Ground Squirrels, Earwigs, Fleas, Grasshoppers, Sod Webworms, Moths. **DEXTOL DEXA-KLOR** in 15 gal. water for each 100 sq. ft. of lawn. 15 gal. water for 1,000 sq. ft. of lawn. Spray when pests first appear; repeat as necessary. Apply as a coarse spray using a hose end sprayer. Thoroughly wet immediate treatment areas. For best results, the lawn should be mowed before treatment. One application usually will kill Crickets, Bugs for up to 8 weeks. For Sod Webworms, spray water 1,000 sq. ft. of lawn 10 to 12-24 hours after treatment. For Fleas, use 15 gal. water for 1,000 sq. ft. of lawn 10 to 12-24 hours after treatment. For Ants, use 15 gal. water for 1,000 sq. ft. of lawn 10 to 12-24 hours after treatment. Use this product in the lawn when the grass is dry and the soil is moist. Do not use in areas where there are children, pets, or other animals. For best results, the lawn should be mowed before treatment. One application usually will kill Crickets, Bugs for up to 8 weeks. For Sod Webworms, spray water 1,000 sq. ft. of lawn 10 to 12-24 hours after treatment. For Fleas, use 15 gal. water for 1,000 sq. ft. of lawn 10 to 12-24 hours after treatment. For Ants, use 15 gal. water for 1,000 sq. ft. of lawn 10 to 12-24 hours after treatment.

PESTS OF DOORS—For control of Ants, Brown Dog Fleas, Fleas, Grasshoppers, Sod Webworms, Moths, Mosquitoes, Spiders and Scorpions. Mix 2 1/2 oz. in 15 gal. water. Apply as a spray or with a paint brush to outside surfaces of buildings, porches, screens, window frames, leaves, gates and garages. Repeat as needed.

FOR OUTDOOR CONTROL OF FLEAS AND TICKS—In Turf: Apply 1 1/2 oz. of **DEXOL DEXA-KLOR** in 70 gal. water as a coarse, low pressure spray to cover 2,000 sq. ft. Mix 1/2 oz. of **DEXOL DEXA-KLOR** in 6 gal. water covers 200 sq. ft. Repeat as necessary. Thoroughly wet immediately after treatment to wash the insecticide into the treated area. For best results, the lawn should be mowed before treatment. See note below on **Animals and Dog Houses**. Apply 1 1/2 oz. of **DEXOL DEXA-KLOR** in 1 gal. of water to building, resting areas, walls and doors. For bedding or nests, use a brush to apply and wash immediately after treatment. See note below.

NOTE—Remove pets before spraying. Do not treat pets with this product. Keep children and pets out of treated areas until spray has dried.

NOTE—To help prevent infestation of buildings by Ants, Crickets, Fleas, Fleas, Moths and Scorpions, treat a hard surface (6-10 ft. wide and at least 2 ft. high) of the foundation. Mix 2 1/2 oz. in 12 gal. water and thoroughly apply as a coarse spray over 1,000 sq. ft. of area.

TO CONTROL FIRE ANTS—Dilute 2 1/2 oz. of **DEXOL DEXA-KLOR** in 1 gal. of water. Apply 1 gal. of solution as a gentle rain to each Fire Ant mound using a sprayer can. Thoroughly wet mound and surrounding area (2-4 ft. diameter) 3-5 gal. in for best results; apply in cool weather. 65-80°F. Do not spray in morning or late evening hours. If a new mound is seen, apply immediately. Do not disturb the mound until treatment is possible. Treat all mounds in the vicinity and treat all colonies which may have yet to be constructed or mound.

Keep children and pets off treated areas until spray has dried. An irritating pesticide may be in the eye via contaminated footwear.
