

SHAKE WELL BEFORE USING

DEXOL HOME INSECT KILLER is a water based, ready-to-use insecticide that effectively controls listed pests in and around the home. This non-staining formula can be used for spot freatment indoors on carpets, upholstery, around window and door frames, behind sinks, stoves, refrigerators as well as outdoors on porches, in garages, on weeds, lawns and soil areas. Spray surfaces until wet and repeat as needed. Spot test for color fastness before spraying.

PESTS INDOORS: Do not allow spray to contact food, foodstuffs and water supplies. Thoroughly wash dishes and food handling utensils with soap and water if they become contaminated. Remove pets and cover fish tanks before spraying.

Cockroaches, Arts, Clover Mites, Crickets, Firebrats, Silverfish and Spiders—Apply as a spot treatment only using a coarse spray to localized areas where insects are found or normally occur including dark corners of rooms and closets; cracks and crevices in walls; along and behind baseboards; beneath and behind sinks, Stoves, refrigerators and cabinets; around plumbing and other utility installations. Carpet Beetles -- Thoroughly apply as a spray along baseboards and edges of carpeting, under carpeting, rugs and upholstery in closets and on shelving, and wherever else these insects are seen or suspected.

Fless and Brown Dog Ticks—Use DEXOL HOME INSECT KILLER as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices; along and behind baseboards, window and door frames, uphotstery and localized areas of floor and floor coverings where these pests may be present. Repeat treatment in 7-10 days as necessary. Keep children and pets out of sprayed areas until dry. Old bedding of pets should be removed and replaced with clean, fresh bedding after treatment of pet area.
