Subject: Amended label to add pet application to Dexol Carpet
Dust EPA Reg. No. 192-170.

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Five copies of the finished labeling must be submitted prior to releasing the product for shipment.

Modify the Container Disposal statement to read as follows:
Securely wrap original container in several layers of newspaper and discard in trash.

Modify the Precautionary Statements to read as follows:
CAUTION: Harmful if swallowed, inhaled or absorbed through the skin. Avoid contact with skin, eyes, or clothing. Avoid breathing dust. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

Remove the discussion of food and feedstuffs to the directions for use.

The statement of Practical Treatment for oral ingestion must be modified to delete the word "immediately."

The statement of Practical Treatment for skin effects must be modified to add the following: "Get medical attention if irritation persists."

The ingredient statement must be modified to delete the word "technical" from piperonyl butoxide.

DIRECTIONS FOR USE: It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Dexol Carpet Dust provides an effective and easy way to kill Fleas, Ticks, Roaches, Ants, Lice and Silverfish that live and breed in carpets and upholstery. This combination of the natural insecticide pyrethrin with a deodorizing agent and pleasant fragrance leaves treated areas with a fresh clean scent.

HOW TO USE: Shake container before using. Remove plastic seal and sprinkle evenly onto carpets at the rate of 4 oz. to 100 sq. ft. Brush lightly with a broom to allow product to penetrate carpet fibers. Allow product to remain on the carpet for at least 60 minutes and then vacuum away. Reapply as needed to maintain control. **NOTE:** For severe infestations, allow product to remain on carpet 2-3 hours before vacuuming.

FOR USE ON UPHOLSTERY: Remove all loose cushions. Sprinkle along creases and into corners. Brush gently, wait 60 minutes and vacuum away. Also apply along underside of furniture. **Do Not** use on exposed fabric; may cause staining.

IMPORTANT: Do not allow product to become wet. If product adheres to a spot, brush it out and vacuum immediately. **Apply to dry surfaces only.** Test on hidden surface of carpet or upholstery before applying. If texture or color is affected, do not use. Always remove bag from vacuum cleaner after use. Wrap bag securely in several layers of newspaper and discard in trash.

FOR FLEA CONTROL ON DOGS AND CATS: Hold can upside down and sprinkle powder over animals back; head to tail; around the neck and ears, the underbelly, the legs, the base of the tail and where fleas are seen; keeping out of pet's eyes and face. Rub in against the lay of the hair until powder penetrates to skin. In addition to fleas; ticks and lice will also be killed when contacted by the powder. Do not treat puppies or kittens under 4 weeks old. Treat pet sleeping quarters and replace with freshly laundered bedding.

STORAGE AND DISPOSAL

Storage: Store in a cool, dry place.
