DIRECTIONS FOR USE: It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Dexol Weed & Grass Killer is a non-selective ready to use herbicide that top kills weeds and grasses on contact. Its phytotoxic properties are quickly inactivated on contact with soil. Treated areas may be reseded within 3 to 5 days if desired. Apply as directed to control unwanted vegetation around trees, shrubs, buildings, in brick and gravel walks, patios and along fences, sidewalks, driveways, curbs and gutters. Will not stain gravel or paved areas. Use to keep grasses from creeping into unwanted areas.

WHEN TO APPLY: Apply anytime during the growing season, however, best results are obtained during warm, sunny weather and when unwanted vegetation is actively growing. Avoid drift to desirable plant foliage. Apply only when air is calm. Heavy lawn grass and difficult to control perennial weeds such as Bermudagrass and Dallisgrass will require more than one application to give complete control of top growth.

[NOTE: The following two (2) paragraphs will be used on the labels of products sold with a sprinkle top applicator].

HOW TO APPLY: Remove cap from applicator head and be certain that applicator head is screwed firmly on jug. Invert jug and apply product to thoroughly cover unwanted vegetation. The width of the spray pattern may be adjusted by either raising or lowering the jug. For top killing vegetation around trees, shrubs and buildings and edging around lawns, fences and sidewalks, hold jug about 2 to 6 inches from the area to be treated depending upon desired width.

For controlling weeds in brick and gravel walks and patios and in other confined areas, hold jug at about waist height, away from body, to avoid contact with skin or clothing. Walk slowly making sure that all undesirable plants are thoroughly covered with spray. Apply 1 gallon to cover 200 square feet. For spot treating or retreating missed areas, hold jug so that spray hits only the weed or area to be treated. Under warm, sunny conditions wilting will occur in 1 to 3 days and complete browning in 5 to 7 days.

[NOTE: The following paragraph will be used on the labels of products; sold with a trigger sprayer].

HOW TO APPLY: Apply with the hand trigger sprayer. Spray hozzle should be adjusted to allow a coarse spray. Spray areas occupied by unwanted weeds or grasses. Stand close to weed (1 to 2 feet), with spray nozzle aimed at weed and away from face. Spray to thoroughly wet; unwanted weeds and grasses. Under warm, sunny conditions wilting will cocur in 1 to 3 days and complete browning in 5 to 7 days.

IMPORTANT: To avoid drift that may injure desirable plants, do not apply during windy weather. Make sure spray mist does not contact the leaves, green bark, bud crowns or broken bark on trees and ornamentals. Do not apply on or around plants to be used for food or feed. Do not track from treated areas to untreated areas.

#### STORAGE & DISPOSAL

Storage: Keep pesticide in original container. Store in a locked storage area inaccessible to children and pets. DISPOSAL: Do not reuse empty container. Wrap container and put in trash collection.
