DIRECTIONS FOR USE: It is a violation of Federal law to use this product in a manner inconsistent with it's labeling. **This product is only for use around the outside of homes.**

GENERAL: Dexol Weed & Grass Killer is a non-selective, ready-to-use herbicide that kills (desiccates) weeds and grasses on contact. It's phytotoxic properties are quickly inactivated on contact with soil and will not harm roots of non-target plants. Grasses and weeds will begin to wilt after 8 hours with complete death (of most weeds), within 1-3 days; at which time treated areas may be re-seeded. Apply as directed to kill unwanted vegetation around trees, shrubs, walks, drives, curbs, gutters, fences and patios. Difficult to control weeds such as Bermudagrass and Dallisgrass may require more than one application to give complete control. Will not stain gravel or paved areas. Use to keep weed and grasses from creeping into unwanted areas.

WHEN TO APPLY: Apply anytime unwanted vegetation is actively growing. For fastest results, apply in full sun when temperature is above 60°F. **DO NOT** allow spray to contact or drift to desirable foliage. Respray perennial weeds when green reappears.

THE FOLLOWING TWO (2) PARAGRAPHS WILL BE USED ON THE LABEL OF PRODUCT SOLD WITH A SPRINKLE TOP APPLICATOR

HOW TO APPLY: Remove cap from jug and check applicator head to make certain that it is firmly attached to jug. Invert jug and apply product to thoroughly cover unwanted weeds and grasses. The width of the sprinkle pattern may be adjusted by either raising or lowering height of jug from the treatment area. For controlling weeds and grasses around trees, shrubs, and buildings and edging around lawns, fences, walks, and drives, hold jug 2-6 inches above area to be treated. Adjust jug height for desired width of coverage.

For controlling weeds and grass in patios, brick and gravel walks and other confined areas, hold jug about waist height and away from body to avoid contact with skin and clothing. Walk slowly making sure that all undesirable plants are thoroughly covered. Apply at a rate of 1 gallon to cover 200 square feet. For spot treating or retreating missed areas, hold jug so that spray hits only the weed or area to be treated. **ENTRY RESTRICTIONS:** Do not allow people or pets to touch treated plants until the sprays have dried. Do not apply this product in a

way that will contact any person or pet, either directly or through drift. Only persons applying this product may be in the area during application.

THE FOLLOWING PARAGRAPH WILL BE USED ON THE LABEL OF PRODUCT SOLD WITH A TRIGGER SPRAYER

HOW TO APPLY: Apply with the trigger sprayer. Spray nozzle should be adjusted to allow a course spray pattern. Spray areas occupied by unwanted vegetation. Stand close (1-2 feet), with nozzle aimed at weed or grass and away from face. Spray thoroughly to wet undesirable vegetation.

IMPORTANT: Do not allow this product to contact or drift onto desirable vegetation. Do not apply during windy weather. Make sure spray mist does not contact the leaves, green bark, bud crowns or broken bark on trees or other desirable plants. Should contact occur, wash off immediately with water. Do not track from treated to untreated areas. **ENTRY RESTRICTIONS:** Do not allow people or pets to touch treated plants until the sprays have dried. Do not apply this product in a way that will contact any person or pet, either directly or through drift. Only persons applying this product may be in the area during application.

STORAGE & DISPOSAL

STORAGE: Keep this product in original container. Store in a locked storage area inaccessible to children and pets. **DISPOSAL:** Do not reuse empty container. Wrap container in several layers of newspaper and discard in trash.

HAZARDS TO HUMANS AND DOMESTIC ANIMALS
