Harmful if swallowed, inhaled or absorbed through skin. Avoid breathing vapor or spray mist. Avoid contact with eyes, skin and clothing. Wash thoroughly with soap and water after handling and before eating or smoking. Remove and wash contaminated clothing before reuse. May cause contact sensitization following repeated contact with skin of susceptible individuals. Avoid repeated contact with skin. If sensitization reactions result, consult a physician.
