 Dexol Ant, Roach & Spider Control
 EPA Registration Number 192-179
 Your submission dated October 11, 1993

This amendment referred to above, submitted in connection with registration under FIFRA section 3(c)(7)(a), is acceptable, provided that you:

1. Submit and/or cite all data or other material required for registration/reregistration of your product under FIFRA section 3(c)(5) or FIFRA section 4 when the Agency requires all registrants of similar products to submit such data.
2. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:

a. Under **HAZARDS TO HUMANS AND DOMESTIC ANIMALS** change "Harmful if inhaled...until the areas are dry." to read "Harmful if swallowed, inhaled or absorbed through skin. Avoid breathing vapor or spray mist. Avoid contact with eyes, skin and clothing. Wash thoroughly with soap and water after handling and before eating and smoking. May cause contact sensitization following repeated contact with skin of susceptible individuals. Avoid repeat contact with skin. If sensitization reactions results, consult a physician. Remove and wash contaminated clothing before reuse. Remove pets from area, and cover fish bowels before spraying. Keep children and pets off treated areas until areas are dry."

b. Replace **STATEMENT OF PRACTICAL TREATMENT** with the following: " **If swallowed:** Call a physician or Poison Control Center, immediately. Give milk or water. Do not induce vomiting unless no other treatment is available, and then preferable under medical supervision. If it is necessary to induce vomiting, give victim one or two glasses of water and insert finger in back of throat. Do not induce vomiting or give anything by mouth if person is unconscious or convulsing. **If inhaled:** Remove victim to fresh air and apply artificial respiration if indicated. **If on skin:** Wash promptly with soap and water. Rinse thoroughly. **If in eyes:** Rinse eyes with plenty of water. Get medical attention if irritation develops or persists. **Note to Physician:** This product is an organophosphate insecticide. If symptoms of cholinesterase inhibition are present, atropine sulfate by injection is antidotal. 2-PAM is also antidotal and may be administered but only in conjunction with atropine."

c. Under **General Information** before "There is no need for further dilution." add "Hold container upright and spray into cracks, crevices, and other surface areas as specified in label directions."

d. Under **General Information Cockroaches** after "...sinks, stoves, and similar areas where these insects hide." add "Do not spray inside cabinets where food is stored. Discard infested food packages. Do not spray across top of stove or near pilot lights."

e. Since the product is limited to use in/around homes, delete the statement beginning, "Do not use in food/feed areas of food/feed handling establishments...Do not use in serving areas..."

f. We assume this product will be applied from the original container and is sold with a spray head attachment. Please confirm. Products intended for indoor use by the homeowner should be ready to use and applied from the original container.

g. Under **ENVIRONMENTAL HAZARDS** change "For terrestrial uses...high water mark." to read "Do not apply directly to water."

3. Submit three (3) copies of your final printed labeling before you release the product for shipment. Refer to the A-79 enclosure for a further description of final printed labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Harmful if inhaled or absorbed through skin. Avoid contact with skin, eyes, or clothing. Avoid breathing vapors. Wash thoroughly with soap and water after handling and before eating or smoking. Remove contaminated clothing and wash before reuse. Remove pets from area, and cover fish bowls before spraying. Keep children and pets off treated areas until the areas are dry.

STATEMENT OF PRACTICAL TREATMENT

If in eyes: Flush eyes with plenty of water. Call a physician if irritation persists. If inhaled: Remove victim to fresh air. If on skin: Wash with plenty of soap and water. Note to Physician: Diazinon is an organophosphate insecticide. If symptoms of cholinesterase inhibition are present, atropine sulfate by injection is antidotal. 2-PAM is also antidotal and may be administered, but only in conjunction with atropine.

ENVIRONMENTAL HAZARDS

This product is highly toxic to fish, birds and other wildlife. For terrestrial uses, do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not contaminate water by disposal. This pesticide is highly toxic to bees exposed to direct treatment or to residues on blooming plants when they feed. Do not allow this pesticide to drift to blooming weeds, if bees are visiting the treatment area. Do not apply this product to or allow it to drift to food crops or any desirable vegetation at any time.

PHYSICAL OR CHEMICAL HAZARDS

Do not use or store near heat or open flame.

DIRECTIONS FOR USE: It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

General Information: Dexol Ant, Roach & Spider Control is a ready-to-use microemulsion product containing diazinon. There is no need for further dilution. This product is intended for use inside the home and for limited use outside the home as a spot treatment to house foundation walls and around windows and doors for the control of those pests specified on this label.

Indoor Use: Controls - Cockroaches (waterbugs), ants, silverfish, carpet beetles, spiders, scorpions, and exposed stages of sawtoothed grain beetle, rice weevil, cigarette beetle, drugstore beetle, and indian meal moth.

Precautions: (1) Do not use this product indoors as an overall surface spray or as a space spray; take care not to introduce this product into the air during application. (2) Use only in well-ventilated areas. (3) Do not apply where children are likely to frequently contact treated surfaces. (4) Remove or cover fish bowls and remove pets before application. (5) Do not treat pets or plants with this product. (6) Do not allow children or pets in treated areas until spray has dried. (7) If clothing is sprayed during application, remove clothing immediately after spraying and launder

before wearing again. (8) Avoid excessive wetting of carpets or floor coverings and unfinished materials. (9) Care should be taken to avoid spotting of walls, wall coverings, and fabrics. (10) Do not apply directly to upholstery, furniture, leather, draperies, or stained surfaces because damage may occur. (11) Do not apply to areas, surfaces, or utensils which will contact food or feed. (12) Exposed food should be covered or removed during application. (13) All food processing surfaces and utensils should be covered during application or thoroughly washed with soap and water before use. (14) Do not use this product in conduits, motor housings, or electrical switch boxes. (15) Do not use in edible product areas of food processing plants, restaurants, or other areas where food or feed is commercially prepared or processed. (16) Do not use in serving areas while food is exposed.

Cockroaches (Waterbugs), Ants, Silverfish: Make spot applications of Dexol Ant, Roach & Spider Control to baseboards, areas around water pipes, cracks and crevices, surfaces behind and beneath cabinets, refrigerators, sinks, stoves, and similar areas where these insects hide. Spray areas until wet. Repeat application as necessary to maintain control.

Carpet beetles: Spray Dexol Ant, Roach & Spider Control in spot applications along baseboards and edges of carpeting, under carpeting, rugs and furniture, in closets and on shelving, and wherever these insects are seen or suspected.

Spiders and Scorpions: Spray Dexol Ant, Roach & Spider Control around windows, doors, and along baseboards. Make spot applications to other areas over which these pests may crawl.

Brown dog ticks, Fleas*: Apply Dexol Ant, Roach & Spider Control to infested areas around baseboards, window and door frames, wall cracks, sleeping quarters of household pets, and localized areas of floors and floor coverings. Fresh bedding should be placed in animal quarters following treatment. Do not treat animals with this product. Repeat as necessary.

*Controls adult fleas on areas treated.

Pantry Pests - Exposed Stages (Sawtoothed grain beetle, flour beetle, rice weevil, cigarette beetle, drugstore beetle, indian meal moth): Spray Dexol Ant, Roach & Spider Control on shelves and in cupboards where food containers suspected of being infested are stored. Remove all food and shelving paper before spraying. Do not replace the food packages until spray had dried. Cover shelves with shelving paper. This treatment is supplemental to good housekeeping, since it will have no effect on insects breeding within food packages. Infested food packages should be destroyed.

OUTDOOR USE

Precautions: (1) Spray with wind to your back. If clothing becomes wet from spray during use, remove clothing after spraying,

wash affected body areas thoroughly with soap and water, and launder clothing before wearing again. (2) Do not allow children or pets to contact treated areas until spray has dried. (3) Do not apply to lawns or other desirable plants.

House Foundation Treatment

This product will control ants, boxelder bugs, brown dog ticks, chiggers, clover mites, cockroaches, crickets, earwigs, fleas, flies, millipedes, sowbugs, spiders, and collembola (springtails) which are commonly found near the house and may enter the home. Apply as a spot treatment to house foundation walls and around doors and windows where these pests are likely to enter. Repeat application as necessary.

STORAGE & DISPOSAL

Storage: Keep from freezing. Store above 32°F. Store in an area inaccessible to children and pets. Disposal: Do not reuse empty container. Rinse thoroughly before discarding in trash. Securely wrap original container in several layers of newspaper and discard in trash.
