Hazards to Humans and Domestic Animals

CAUTION: Wash thoroughly after handling and before smoking or eating. Avoid contamination of feed and foodstuffs. Remove pets and birds and cover fish aquaria before surface applications. Do not use on humans, **Do not allow children or pets to contact treated areas until surfaces are dry.**

FOR HOUSEHOLD USE ONLY: For use in homes, apartments, attics, basements, campers, boats, household storage areas, garages, pet sleeping areas, cabins.

INDOOR USE: for spot application only. Do not use as a space spray indoors.

Cockroaches, Waterbugs, Palmetto Bugs, Scorpions, Millipedes, Centipedes, Sowbugs, Pillbugs, Ants, Silverfish, Firebrats, Spiders, Crickets, Clover Mites, Cheese Mites, Granary Weevils, Rice Weevils, Confused Flour Beetles, Rust Red Flour Beetles, drugstore Beetles, Mealworms, Grain Mites and Cadelles.

COCKROACHES (WATERBUGS), ANTS, SILVERFISH: make spot applications of this product to baseboards, areas around water pipes, cracks and crevices, surfaces behind and beneath cabinets, refrigerators, sinks, stoves, and similar areas where these insects hide. **Ants:** To kill ants, spray trails, nests and points of entry within buildings and homes. Spray directly on insects where possible. Repeat application as infestations occur.

CARPET BEETLES: spray in spot application along baseboards and edges of carpeting, under carpeting, rugs and furniture, in closets and on shelving, and wherever these insects are seen or suspected.

SPIDERS AND SCORPIONS: Spray around windows, doors, and along baseboards. Make spot applications to other areas over which these pests may crawl.

BEDBUGS: spray mattresses lightly, particularly around tufts and seams. Take beds apart and spray in all joints. Treat baseboards, molding and floors. Repeat treatment as infestations occur. FLEAS (Adult and larvae), BROWN DOG TICKS: apply to infested areas, around baseboards, windows and door frames, wall cracks, sleeping quarters of household pets, and localized areas of floors and floor coverings. Fresh bedding should be placed in animal quarters following treatment. NOTE: Always spot test for color fastness of surfaces prior to making a full treatment. Repeat as infestations occur. Allow to dry thoroughly before allowing children of person treated areas.

PANTRY-PESTS EXPOSED STAGES (Saw-toothed Grain Beetle, Flour Beetle, Tice-Weevif, Cigarette Beetle, Drugstore Beetle, Indian Meal Moth): Spray this product on shelves and in cupboards where food containers suspected of being infested are stored. Remove all food and shelving paper before spraying. Do not replace the food packages until spray has dried. Cover shelves with shelving paper. This treatment is supplemental to good housekeeping, since it will have no effect on insects breeding within food packages. Infested food packages should be destroyed.

OUTDOOR USE: Use this product to control Cockroaches, Waterbugs, Palmetto Bugs, Scorpions, Millipedes, Centipedes, Sowbugs, Pillbugs, Ants, Silverfish, Firebrats, Spiders, Crickets, Clover Mites, and Cadelles. To help prevent infestation of building, treat the building foundation to a height of 2-3 feet, where pests are active and may find entrance. Also apply as a residual spray to outside surfaces of building, including porches, screens, window frames, eaves, patios, garages, refuse dumps, and other areas where these pests congregate or have been seen. Repeat treatment as infestations occur.

TICKS: To help control ticks in outdoor activity areas, treat a band of vegetation 6-8 feet wide and adjacent to activity areas, especially where dense vegetation occurs. Not for use on ornamentals grown for sale or for commercial seed production or for research purposes.

GARDEN INSECTS: Use this product to control Whiteflies, Spider and Red Mites, Exposed Thrips, Lace Bugs, Japanese Beetles, Pavement Ants, Clover Mites, Armyworms and Leafminers on: African Violets, Asters, Azaleas, Begonias, Camellias, Carnations, Chrysanthemums, Dahlías, Delphiniums, Dogwoods, English Ivy, Euonymus, Fuchsia, Geraniums, Crassula, Grape Vines, Kentia Palms, Laurels, Marigolds, Rhododendrons, Roses, Rubber Plants, Snapdragons, Stocks, Wandering Jews, and Zinnias. Spray at the first sight of insects, before infestation is heavy. Repeat as infestation occur. When spraying plants, do not operate closer than 18 inches. Use sweeping motion. Be cautious about wetting tender foliage, young plants, and new growth. Do not spray plants, and new growth. Do not spray plants when temperatures exceed 90°F. Contact insects directly whenever possible.

STORAGE & DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store in a cool, dry area away from heat or open flame. Keep in original container and preferably in a locked storage area inaccessible to children and pets.
