Do not apply this product in food areas of food handling establishments. Do not use as a space spray. Do not allow children or pets to contact treated surfaces until they are dry.

FOR SPOT APPLICATION: To Kill Ants, Cockroaches, Crickets, Silverfish, Sowbugs, Pillbugs, Earwigs, Firebrats, Clover Mites, and Spiders (including Black Widow Spider) and Scorpions:

Spray areas where these pest are seen or where they may hide, such as dark corners of rooms, in closets, along baseboards, along and around door and window frames, behind and beneath sinks, stoves and refrigerators, in wall voids, around plumbing and utility installations, and around garbage cans.
