

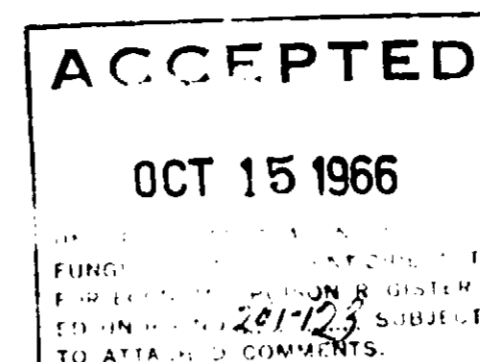

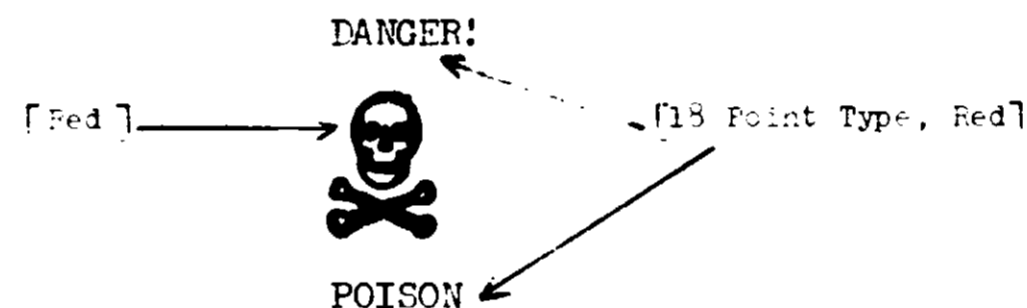

POISONOUS IF SWALLOWED, INHALED OR ABSORBED THROUGH SKIN! KEEP OUT OF REACH OF CHILDREN AND DOMESTIC ANIMALS. Do not breathe dust. Do not get in eyes, on skin or on clothing. Wear clean clothing. During prolonged exposure in mixing and loading operations, wear clean rubber gloves and a mask or respirator of a type passed by the U.S. Department of Agriculture for dieldrin protection. In case of spillage on person or clothing, immediately remove clothing and flush skin or eyes with plenty of water; for eyes, get medical attention.

ANTIDOTE AND FIRST AID TREATMENT

CALL A PHYSICIAN IMMEDIATELY IN ALL CASES OF SUSPECTED POISONING.

INTERNAL: If the material has been swallowed, induce vomiting immediately. This may be done by introducing a finger into the throat or by giving warm salt water (1 tablespoon of salt to a glass of water). Repeat until vomit fluid is clear. NEVER GIVE ANYTHING BY MOUTH TO AN UNCONSCIOUS PERSON. Keep patient prone and quiet.

TECHNICAL DIELDRIN (Cont'd.)

EXTERNAL: If spilled on the skin, remove all contaminated clothing and wash skin with soap and running water. If the material gets into the eyes, wash immediately with running water for at least 15 minutes.

NOTE TO PHYSICIAN

In case of poisoning, administer barbiturates as for anti-convulsant therapy. Observe patient carefully because repeated treatment may be necessary.
