

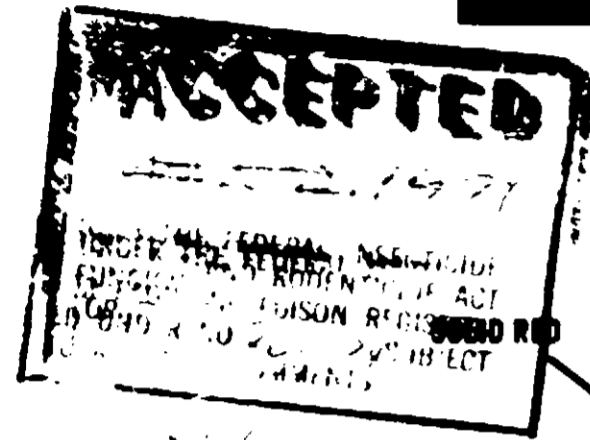

GENERAL DIRECTIONS

For foliage application by aerial or ground equipment, GARDONA solution may be used undiluted or by dilution with diesel fuel No. 2 for the control of gypsy moth and forest tent caterpillar. It may also be used for the control of fall cankerworm in Virginia (only) when diluted with diesel fuel oil No. 2.

USE AND DIRECTIONS FOR APPLICATION

GARDONA is for use on forest and shade trees in the control of gypsy moth and forest tent caterpillar. Use 1 pint/acre of GARDONA 4 lb./gal. solution to control moderate infestations; for heavy populations it may be necessary to use 1 quart/acre. Apply to give uniform coverage. Repeat if necessary to obtain control. Do not spray over cars as paint may be spotted.

GARDONA may be used in Virginia (only) for fall cankerworm control when diluted with diesel fuel oil No. 2. Use 1 pint to 1 quart of GARDONA 4 lb./gal. solution in 1 gallon of diesel fuel oil No. 2 per acre.
