GENERAL DIRECTIONS

STABLE SPRAY is a specially prepared ready-to-use insecticide for use in conventional hand or power spray equipment, electric misters, and foggers.

USE DIRECTIONS

Apply STABLE SPRAY as a fog mist at the rate of one pint for every 8,000 cubic feet (40' x 20' x 10'). Before applying, reduce air movement as much as possible by closing doors, windows, and other openings.

PRECAUTIONS IN USING

HAZARDOUS IF SWALLOWED, INHALED, OR ABSORBED THROUGH THE SKIN. In case of contact with skin or eyes, flush with plenty of water, for eyes get medical attention. Wash thoroughly with soap and water after handling and before eating or smoking. If swallowed, induce vomiting immediately and get medical attention. Atropine is antidotal.
