

GENERAL DIRECTIONS

The Shell Cattle Duster is a ready-to-use livestock dusting device that can be used continuously. No withdrawal period is necessary when used on animals being milked or fed for slaughter. When suspending bag, use a strong rope and weave it through the four metal grommets tying a knot in front of each outer grommet to keep bag from sagging.

USE DIRECTIONS

Forced Use—Suspend Shell Cattle Dusters in barn door exits or alleyways leading from animal buildings, salt blocks, watering holes, or wherever animals are forced to pass under the bags.

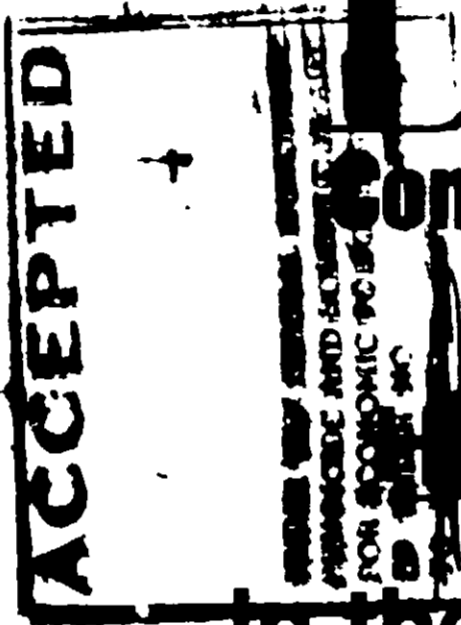
If cattle have never been under the bags before, hang bags above animal's head for the first few days then gradually lower it until it is 4 to 6 inches below their top line.

Free Choice—Hang Shell Cattle Dusters in loafing sheds, feedlots, or in pasture areas where cattle tend to congregate such as in shady spots, near mineral blocks, or watering holes. Controls horn flies and aids in the control of face flies and lice.
