The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, to provide a revised basic "Confidential Statement of Formula" (CSF) dated 9/3/03, is acceptable with the following requirement.

Before the alternate source of unregistered active ingredient can be used, it must have an EPA Establishment Number, and the final printed label must list this new EPA Establishment Number.

Your Amendment Dated 9/8/03 (Revised label)

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, to provide a revised label which adds a clothing related sentence at the end of the "Precautionary Statements", is acceptable.

DIRECTIONS FOR USE

1. This additive is for use in liquid hydrocarbon fuels including jet fuel, diesel fuels, marine fuels and fuel oils for anti-microbial control of fungi and bacteria found in hydrocarbon fuel systems and/or for anti-icing control. Also recommended for anti-icing control in gasolines.
2. For both anti-microbial and anti-icing control, use in concentrations of 0.10 to 0.15% by volume. Do not mix or blend this product with any fuels unless using a closed delivery system. Blend with fuel continuously and incrementally with good mixing. Do not dump concentrated additive unmixed into fuel tanks. Do not allow concentrated additive to contact coated interiors of fuel tanks or painted surfaces. Refer to advice of equipment and/or engine manufacturers or to regulations of applicable government agencies regarding use for each particular fuel.
3. **Attention:** Emptied tote, tanker truck or rail tanker car retains vapor and product residue. Do not cut or weld on or near these.

STORAGE AND DISPOSAL
