  - c. The sentence, this product is toxic to fish and wildlife, should be moved under the paragraph Environmental Hazards.
- 3. Submit five (5) copies of your final printed labeling before you release the product for shipment.

As a planter box treatment use 4-5 ounces per bushel of seed corn. Use only on seed that has been previously treated with a fungicide. Best results are obtained by mixing in a separate container prior to putting seed corn in planter- box. Do not mix with bare hands.

FOR PROTECTION OF GERMINATING SEEDS AND SEEDLINGS AGAINST SEED CORN MAGGOTS ON CORN, PEAS, SOYBEANS AND BEANS (Snap, Lima, White and Kidney)
