Riverdale DiBro Granular is a non-selective herbicide for controlling a wide range of annual and perennial weeds and grasses. It is recommended only for noncropland areas such as railroad rights-of-way and industrial areas 2000 to 4000 pound applications of Riverdale DiBro Granular per acre usually results in a non-productive condition of the soil for a period of a year or more. The duration of non-productivity is dependent upon rainfall, soil type and other conditions.

Riverdale DiBro Granular should be applied as furnished with a seed spreader, a fertilizer spreader, a shaker-type applicator, or with any equipment which will distribute the chemical uniformly over the area to be treated. 
