

Cool Season Grasses - such as bluegrass, fescue, and ryegrass: For normal application, use Weedestroy Tri-Ester II at a rate of 2-4 pints per acre in sufficient water for good coverage, 20-200 gallons of water per acre (3/4 - 1.4 ounces in 1-6 gallons of water per 1000 square feet is normal).
