When applied according to these directions this product can be used safely on the following turfgrass varieties: Perennial Bluegrass varieties, Perennial Ryegrass varieties, Bermudagrass, Bahiagrass, Centipedegrass, Fescue varieties, St. Augustinegrass & Zoysiagrass lawns and ornamental turf. Will not harm most nearby ornamental trees and shrubs when used as directed.

#### WEEDS CONTROLLED

This product contains a combination of Benefin and Trifluca in pre-emergence Herbicide plus a 25-3-3 Lawn Food. It should be applied to established turf for the control of Crabgrass (Smooth and Hairy), Goosegrass (Silver Crab or Crowfoot), Barnyardgrass (Watergrass), Foxtail (Green and Yellow), and Annual Bluegrass (Poa Annua) and provides a complete lawn fertilization.

#### WHEN TO APPLY

Apply to turf prior to germination of weed seeds since established weeds will not be controlled. Apply only to healthy established turf grass lawns.

#### **IMPORTANT PRECAUTIONS:**

DO NOT apply in the spring to Bermudagrass which has been overseeded with winter grasses (annual rye) since thinning will occur. DO NOT use on Dichondra, nor on newly sprigged areas of Bermudagrass, St. Augustinegrass or Centipedegrass, until these turfs are well established, nor to Bentgrass or Putting Greens. DO NOT apply in spring to Turfgrass planted the previous fall. This product may thin established Annual Bluegrass (Poa Annua) & Fine-Leafed Fescue lawns when used at higher rates that 158 lbs. per acre. (2.0 lb. A.I. Per Acre). Do not overdose.

#### WHEN AND HOW TO TIME YOUR APPLICATION

Successful pre-emergence control of the annual grass weeds on this label requires proper timing of application. This product must be applied one to two weeks prior to the germination of annual grass weeds. All summer annual grasses do not germinate at the same time. If application timing does not coincide with the normal germination period of any of the annual grassy weeds listed on this label, weed control results may be erratic or poor.

WATER THE LAWN AFTER APPLICATION: It is not necessary but optimum weed control performance will be obtained if treated areas are irrigated with to 1 inch water soon after application. Any cultural practices that disturb he soil such as vorticutting, should be done prior to application of this product.

"SPRING GERMINATING" SUMMER ANNUAL GRASSES: CRABGRASS, FOXTAIL, BARNYARDGRASS:

A. Northern Cool Season Grasses - For pre-emergence control, apply 130 to 174 lbs. per acre, (equal to 1.5 to 2.00 lbs. B. Southern warm season turfgrass - For pre-emergence control apply 174 to 261 lbs. per acre (equal to 2 to 3 4bs. Active Ingredient per acre), in the late winter or early spring one to two weeks prior to the onset of conditions favorable for annual weedy grass seed germination. 50 lbs. will "Weed and Feed" 8,325 to 12,500 sq. ft. Use for 8,325 sq. ft. where turf 's completely overrun by weeds. Use for 12,500 sq. ft. when weeds are sparse r the turf is in a Yearly Crabgrass Control Program.

LATE SPRING, EARLY SUMMER GERMINATING" ANNUAL GRASSES: GOOSEGRASS (SILVER CRAC)

Although classifed as a summer annual grass, goosegrass normally germinates 4 to 6 weeks later than the crabgrass, foxtails and other summer annual grass species. Applications of this product should, therefore, be timed accordingly.

A. Northern cool season twffg:asses - For pre-emergence control, apply 174 lbs. per acre (equal to 2 lbs. Active Ingredient per acre): of this product in late spring or early summer one to two weeks prior to the expected germination period of goosegrass. 10 lbs. will "Weed and Feed" 12,500 cg. ft.

B. Southern warm season turfgrasses - For pre-emergence control, apply 174 to 261 lbs. per acre (equal to 2 to 3 lbs. Active Ingredient per acre) of this product in late spring or early summer one to two weeks pricr to the expected germination of goosegrass. 50 lbs. will "Weed and Feed" 8,325 to 12,500 sq. ft. FULL SEASON CONTROL IN NORTHERN AND SOUTHERN TURFGRASSES

In areas of the United States where pre-emergence control of both early germinating annual grasses (Crabgrass, Foxtails, and Barnyardgrass) and the later germinating Goosegrass is acsired, two applications of this product at the recommended rate spaced 8 to 10 weeks apart may be made to provide full season control of these annual grass species.

POA ANNUA (ANNUAL BLUEGRASS) CONTROL

In areas of heavy infestation of Annual Bluegrass, its elimination will leave areas of thin turf. Employ proper cultural practices to establish a new turf.

Northern cool season torfgrasses - For pre-emergence control apply 174 lbs. per acre (equal to 2 lbs. Active Ingredient per acre) of this product per acre in late summer or early fall and again in late winter or spring one to two weeks prior to expected germination of annual bluegrass. 50 lbs. treats 12,500 sq. ft. of turfgrass area.

outhern warm season furfgrasses - For Pre-emergence control apply 261 lbs. per acre (equal to 3 lbs. Active Ingredient per acre) of this product per acre in the later summer or early fall one to two weeks prior to expected germination of annu bluegrass. In southern areas of the United States where germination of annual bluegrass continues for extended periods of time a second application at 261 lbs. per acre can be made 10 to 12 weeks after the initial treatment. 50 lbs. treats 8,325 sq. ft. of Turfgrass area.

RESEEDING TREATED AREAS: 1. Delay reseeding - 6 weeks when applying at the rate of 130 or 174 lbs. of product per acre (equal to 1.5 to 2.0 lbs.
