For best results, apply to bare ground or when weed growth is just starting. Weeds taller than 4-6 inches should be hoed before treatment or it may be necessary to make a second application. A second application may be necessary to control deep-rooted perennial weeds.

Care must be taken to keep this herbicide away from desirable flower beds, lawns and shrubs. Do not apply over roots of valuable trees or woody ornamental plants...Only apply herbicide outside the dripline of trees. Avoid spray drift to desirable plants; spray when air is calm.

grass as well as the biennials common mullein and wild carrot, use 1-1/3 - 1.8 qts. in sufficient water to get good coverage. Different grades of mineral oil, diesel fuel, petroleum-based oil, fuel oil, or kerosene may be substituted for water. When using sprinkling can, triple ringe and pour ringate on area treated once application is completed. Mix only the quantity needed and use immediately. Do not store dilute solution once container is opened. To minimize lateral movement, sprinkle lightly with a watering can or similar sprinkler device immediately after application.

Under conditions where the rainfall is high and the growing season long, a second application may be necessary to maintain a vegetation free soil surface.

STORAGE AND DISPOSAL

STORAGE: To be stored in original container and placed in an area inaccessible to children.
