 - a. Your non-commercial labeling is primarily intended for residential uses. Thus, for residential products, the Agency has deemed the following sites acceptable: Lawns, Lawns, Ornamental Lawns, Ornamental Turf Lawns, Residential Turf, Established Residential Turf or Residential Turf Lawn. Therefore, please delete all references to Parks, Cemeteries, Golf Courses, and other similar non-crop areas.

- 2. Make the labeling changes listed below to your "Commercial Labels" before you release the product for shipment bearing the amended labeling:
 - a. Please delete the term "similar non-crop areas" under the Directions For Use section. The term should be superceded by "similar turf areas". In addition, since you used the term "such as" you must add the Worker Protection Exclusionary Statement if it is not already on the label. The term "such as" is so broad it implies that the product could be applied to any ornamental turf site including sod farms.
- 3. Please submit one (1) final printed copy of the referenced labels, incorporating the above change, before releasing the product for shipment.
