The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below.

Add the following footnote to the ingredient statement: Contains petroleum distillate

In the First Aid statements, revise the If Swallowed statements to read as follows: If Swallowed: Immediately call a poison control center or doctor. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

Add the following below the First Aid Statements: Note to physician: Contains petroleum distillate – vomiting may cause aspiration pneumonia.

Since this product is a liquid, in the directions for use, use fluid ounces as the appropriate unit of measure.

Correct the first sentence of the third paragraph of the directions for use to read as follows:

To protect dairy stock from horn flies...

Revise the Precautionary statements to read as follows:

Harmful if swallowed or absorbed through the skin. Avoid contact with skin, eyes or clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum or using tobacco. Remove and wash contaminated clothing before reuse.

Add to the beginning of the Environmental Hazards Statements the following: For terrestrial uses:

At the end of the Environmental Hazards statements add the following: Do not contaminate water when disposing of equipment washwater or rinsate.

Riverdale Cattle Spray is a special insecticide formulation compounded for the dairy industry. It contains piperonyl butoxide and pyrethrins. Riverdale Cattle Spray is especially effective for rapid and economical control of horn flies on dairy cattle and for their protection from stable flies, mosquitoes and gnats.

To protect dairy stock room horn flies, houseflies, stable flies, gnats, mosquitoes, spray twice daily just before milking time, using 1 to 2 ounces per head, applied as a light mist. After a week of such treatments, spraying may be reduced to once a day and then if your experience justifies, reduce the spraying to once every other day, and by the 3rd or 4th week, try one treatment every few days. A set rule does not always work, but it has been found that the above timing of treatment is usually sufficient to maintain adequate protection against horn flies and mosquitoes both in the barn and in the pasture. NOTE—This insecticide may be used as an inhibitor of the development of bloodsucking and biting lice on cattle. Spray about 2.5 ounces on mature animal, then brush into the hair thoroughly so as to reach the hide, paying particular attention to infested areas. This treatment should be repeated only when necessary and not more often than once in three weeks. Use Riverdale Cattle Spray in barns, houses and milk houses for effective control of flies. Direct the mist toward the upper portions of the enclosure, filling the air with spray, and using approximately 2 ounces of material for each 1,000 cubic feet of space. Whenever possible, keep door and windows closed for 10 minutes after application. The better control of the mist, the better the results. A repeat application, if necessary, should be made for protection of the animals and the reduction of flies in barns and milk houses.

STORAGE AND DISPOSAL

STORAGE: Store in cool, dry area. Always store pesticides in a secured warehouse or storage building. Do not store near open containers of fertilizer, seed or other pesticides. Containers should be opened in well-ventilated areas. Do not contaminate water, feed or foodstuffs by storage or disposal.
